


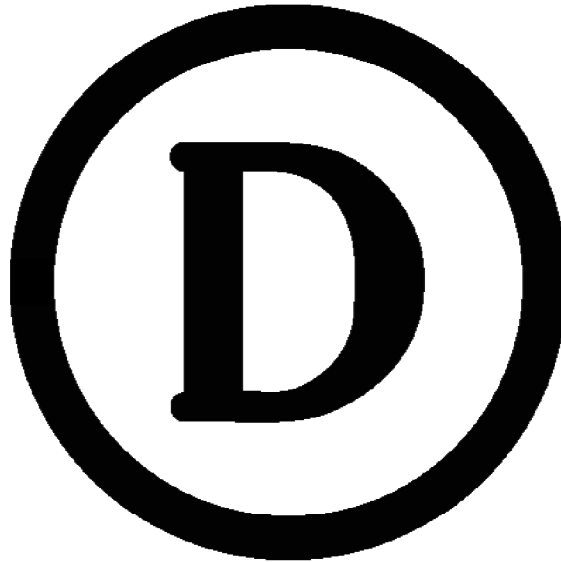

### Certification Mark D-Mark
